

Tax Proofing Your International Offshore Business with Labuan Foreign Company Set

Jurisdictions that allow setting up of foreign company in another jurisdiction with a valid tax residency, this will be ideal for business owners to keep their origin company and able to operate in another jurisdiction for tax proofing to meet economic substance requirements.

The economic substance requirements may vary from one jurisdiction to another. However, according the OECD's BEPS these are six (6) basic requirements to fulfil in the jurisdiction where the business is operating:

Before setting up the foreign company, all offshore entities should consider:

- 1 Whether the entity falls under the economic substance requirements in the registered jurisdiction
- 2 If the entity is permitted under the jurisdiction's law to register the entity as tax resident in another jurisdiction to fulfil the economic substance requirements of the origin jurisdiction

- 1 Submit all info and document required with registration form
- 2 Reserve name (1 day)
- 3 Register company (5-7 days)

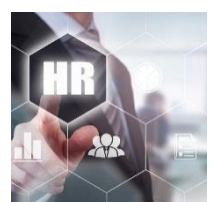

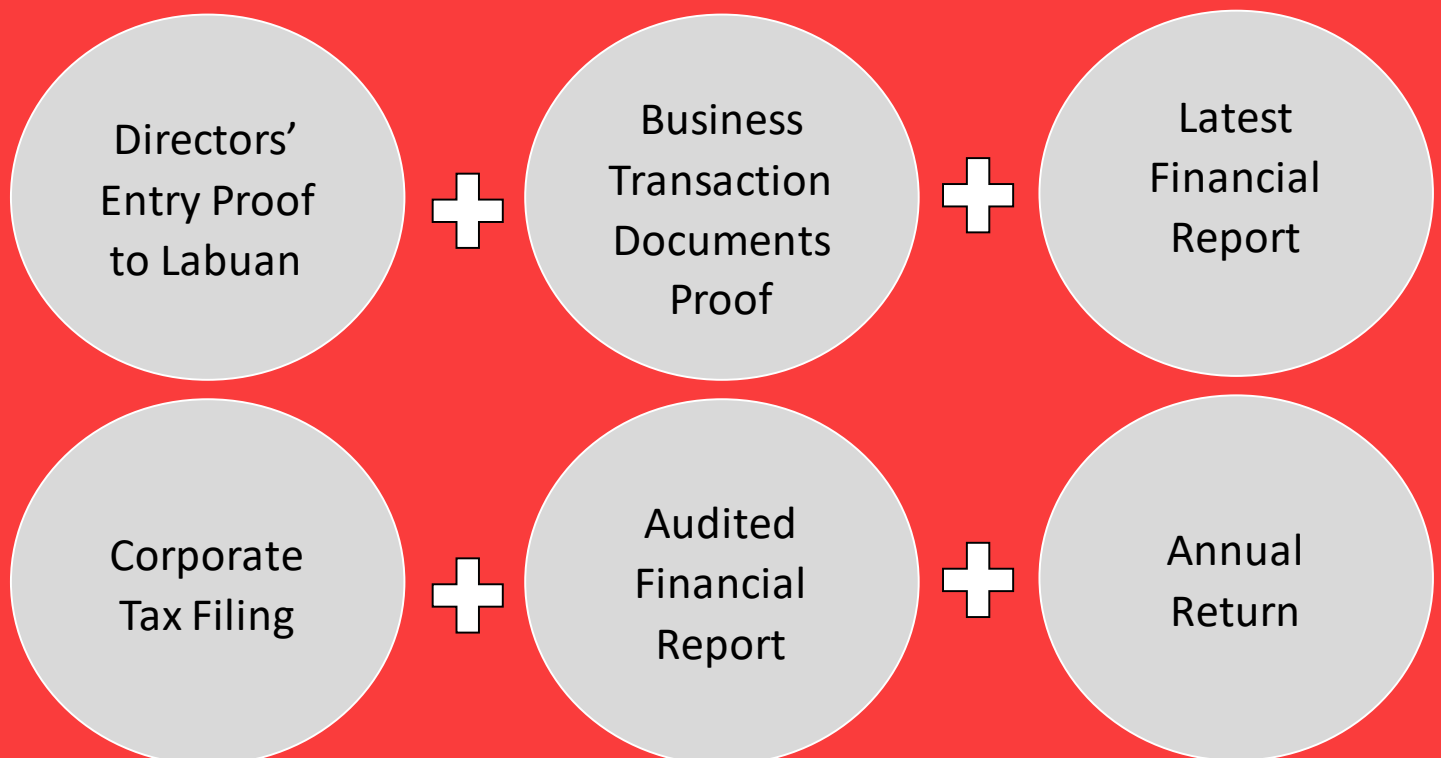
